The following changes, omissions, and/or additions to the Bid Documents shall apply to proposals made for and to the execution of the various parts of the work affected thereby, and all other conditions shall remain the same. All parties of interest shall take careful note of the addendum so that the proper allowances may be made in strict accordance with the Addendum.

Bidder shall acknowledge receipt of this addendum in the space provided on the Bid Form. Failure to do so may subject the Bidder to disqualification.

In case of conflict between bid documents and this addendum, this addendum shall govern.

ITEM #1 The bid deadline for Bid No. 21-22-13NS Dairy and Other Related Items has been changed to Wednesday **May 25, 2022, at 2:00 pm**

ITEM #2 **REVISION TO BID DOCUMENTS: Article 23 QUANTITIES: PRICE ADJUSTMENT:** Revision of the following language:
Prices for Class 1, 2, and 3 products and orange juice may be adjusted during the contract period. Adjustments, either upward or downward, will coincide with the release of the State of California, Department of Food and Agriculture, Announcement of Minimum Prices for Market Milk. All notifications of price adjustments must be made in writing by the Contractor and received by the Director of Nutrition Services at least five (5) working days prior to the effective date of the adjustment.

To be replaced with:

All prices must be firm from July 1, 2022, through December 31, 2022. The District may allow **ONE** price increase after December 31, 2022, with a thirty (30) calendar day written notice. However, a price increase may be allowed based on the percentage of price increase for products that are at or below the consumer price increases for "**All Urban Consumers**" Database Series for the statistical area of "**US City Average**" from the category "**Food Away From Home**" as listed on the Bureau of Labor Statistics (BLS) web site. The Vendor may use the preceding six (6) months, March to September. Vendor may provide alternate
