Parental meetings, such as ELAC and SSC, are held throughout the school year. The school regularly provides opportunities via School Site Council meetings, ELAC meetings, and accreditation meetings.

School administrators and teachers present information through SSC, ELAC, and Parent Empowerment meetings to assist parents in understanding the standards their children must meet and how their child's progress is evaluated. These meetings will focus on the national educational goals, the state/district standards, and the state and local assessments. The school engages Title I, Part A parents in meaningful interactions with the school. Accreditation process informs staff members of the importance in working with all stakeholders to meet the diverse needs of our students and families. The Parent Resource Center and its Outreach Specialist regularly plans opportunities for parents to better understand the resources available to them at the local and state levels. Additionally, the school Outreach Specialist assists parents with referrals to mental health and alternative supports as needed. The site's Mental Health Counselor and Guidance Coordinators also refer students/families to qualifying services.

The school distributes information related to school and parent programs, meetings, and other activities to Title I, Part A parents in a format and language that the parents understand (ESSA Section 1116[e][5]).

Information is distributed via the school website, school marquee, flyers, phone tree, emails, and Q communications.
