ACTION SESSION

* Award Bid #93/05L for Mission Bell Elementary School Modernization: and Bid #93/10L for West Riverside Elementary School Modernization (Mr. Edmunds)

Public bid openings for modernization of Mission Bell and West Riverside Elementary Schools were held on April 21 and 27, 1993, respectively. Submitted bids are as shown in the supporting documents. These bids included Minority/Women Business Enterprise documentation as required and were forwarded to OLA in Sacramento for review and acceptance. Both projects are funded from Leroy Greene Lease-Purchase funds.

The State Allocation Board approved the bids as submitted at their public meeting on Wednesday, June 23, 1993.

Troxler & Sons' base bid of \$800,000 for the Mission Bell Elementary School Modernization Project was over the State allocation of \$737,208.92. However, by approving the bid utilizing deductive alternates B and E, and by the District contributing \$1,491.08, the contract is brought down to \$738,700 (\$1,491.08 above the State allocation).

* Award Bid #93/05L for Mission Bell Elementary School Modernization; and Bid #93/10L for West Riverside Elementary School Modernization (Cont'd)

K & S Investments' base bid of \$226,152 for the West Riverside Elementary School Modernization Project is below the State allocation of \$234,393, allowing for award without utilizing any of the deductive alternates.

Administration recommends the Board award Bid #93/05L for Modernization of Mission Bell Elementary School to Troxler & Sons utilizing deductive alternates B and E with the District contributing \$1,491.08; and Bid #93/10L for Modernization of West Riverside Elementary School to K & S Investments.

The Assistant Superintendent Business Services stated that the State Allocation Board took action at its June 23, 1993 meeting to approve the bids for West Riverside and Mission Bell Elementary School modernizations.

MR. BARNES MOVED THE BOARD AWARD BID #93/05L FOR MODERNIZATION OF MISSION BELL ELEMENTARY SCHOOL TO TROXLER & SONS UTILIZING DEDUCTIVE ALTERNATES B AND E WITH THE DISTRICT CONTRIBUTING \$1,491.08; AND BID #93/10L FOR MODERNIZATION OF WEST RIVERSIDE ELEMENTARY SCHOOL TO K & S INVESTMENTS. MR. CHAVEZ SECONDED THE MOTION WHICH CARRIED UNANIMOUSLY BY THE FOUR BOARD MEMBERS PRESENT.
