### **COMMUNICATIONS SESSION**

### 1. Recognition

- a. Recognize Receipt of Grant at Sunnyslope Elementary School
  Four teachers at Sunnyslope Elementary were recently notified that their application for funding of the Early Intervention for School Success (EISS) Program New Teacher Training Grant had been approved in the amount of \$875 each. Congratulations to Shawnette Bukarau, Carol Hogerty, Miranda Larson, and Carolyn Sherman for their successful application. A copy of the notification letter is included in the supporting documents. Information only.
- b. Recognize Grant Award for Educational Technology
  The district was recently notified that Stone Avenue and Sunnyslope Elementary Schools were selected for funding in the 1997/98 SB 1510 School-Based Education Technology Grants Program. This is a competitive Comprehensive Grant, with a California State Board of Education approved allocation. The purpose of the grant is to improve the quality and effectiveness of instruction and learning with the assistance of technology-based resources. Funds will be used for staff development, local planning and evaluation activities. A copy of the notification of funding letter is included in the supporting documents. Congratulations to Stone Avenue Elementary with a grant award of \$13,625 and Sunnyslope Elementary's grant award of \$18,375. Information only.

### c. Accept Donations

All donations are given to Jurupa Unified School District with the request that the money or item be used at the designated school.

The Camino Real Elementary School PTA wishes to donate \$2,500.00, with the request it be used to purchase a school marquee.

Mr. and Mrs. J. Johnston, of Riverside, wish to donate \$250.00, with the request it be used to purchase instructional supplies for Mrs. Johnston's classroom at Camino Real Elementary School.

California Federal Bank, at the Riverside Plaza, wishes to donate \$500.00, with the request it be used to support the education of students at Rustic Lane Elementary School.

The Sunnyslope Elementary School PTA wishes to donate \$570.30, with the request it be used as the Sunnyslope Student Council determines it is most needed in the 1998-99 school year.

Ms. Whitney Minter, on behalf of The Magazine Processing Center in Tennessee, wishes to donate \$409.51 to Sunnyslope Elementary School. Funds will be used to enhance educational computer programming at the school.

Ms. Teresa Moran, a teacher at Jurupa Valley High School, wishes to donate a number of books, with the request they be used at Jurupa Valley High School. The approximate value of all materials is \$624.00.

Administration recommends acceptance of these donations with letters of appreciation to be sent.

### 2. Administrative Reports and Written Communications

- a. Hear Report on State Pesticide Regulations
  At the request of Board Member Mary Burns, administration has asked a member of the State Pesticide Regulation Board to send representative, Ms. Regina Sarracino, to provide current information on pesticide usage as the District considers appropriate revisions to Board Policy 3401, Pesticide Management. Ms. Sarracino will answer questions relative to long-term studies; pesticide usage in other school districts; which pesticides are harmful and methods that can be safely used for pest control and weed abatement. Information and discussion.
- b. Hear Report on Status of Technology
  In February, 1997, the Board held a special study session to review the District's status in the implementation of technology. At that time, the staff reported on the number and type of computers at various school sites, presented the district's goals for the use of technology as well as its various applications. In addition, Aidco, a communications consulting firm, presented our long range plan for installing a Wide Area Network (WAN) to connect the schools with district facilities, the Riverside County Office of Education and the World Wide Web, commonly known as the Internet. The consultant also outlined plans for installing Local Area Networks (LANs) at each district site to provide connectivity throughout the site and to the district's WAN. The initial cost estimate was \$4 million dollars for complete installation of a district network system. Since adequate funding was unavailable, the staff recommended that the Board consider a phase-in plan.

Since that time, the Board allocated \$500,000 for technology implementation from One-Time Block grant funding; the district received nearly \$700,000 in networking equipment and wiring from the Riverside County Riverlink project and the work on the WAN is nearly complete. Various school sites have received grant funds or have used portions of their One-Time Block grant site funds, or other existing categorical resources such as Title I or School Improvement to purchase computers, other peripherals and software. A position devoted to educational technology implementation was approved and the staff has reviewed and revised its Technology Use Plan and developed a policy and administrative procedures for Internet access.

This report will include an update on the number of computers at each site and technology staff development offerings. The staff will also review the status of the Wide Area Network project including the building modifications necessary to install the network, the Riverlink project, the Netel student data system project and the proposed Cisco Systems, Novell and Microsoft Corporation academies to be located at Rubidoux, Nueva Vista and Jurupa Valley High Schools respectively. District staff will be joined by representatives from various agencies in making the presentations. Information only.

c. Hear Report on Status of S.T.A.R. Test Results Reporting
At the July 7, 1998 meeting, the Board reviewed information on the status of S.T.A.R. test results reporting. At the time, administration reported that individual test results for students in grades 2-11 who took the Stanford 9 test were mailed to parents during the week of June 22, 1998. We also reported that, in light of a recent Superior Court ruling regarding publishing of district scores with L.E.P. scores included, staff contacted the scoring service for Harcourt Brace, publishers of the Stanford 9, to request disaggregated scores. In the interim, our research staff discovered that several of the data disks were flawed and thus returned them to the scoring service for correction. A CD Rom with district scores arrived in the district last week and was sent to a consultant for analysis and preparation of district reports.

### c. Hear Report on Status of S.T.A.R. Test Results Reporting (Cont'd)

The Board should note that, during the first two weeks in July, the California Department of Education sent several conflicting memos regarding release of test results. Initially, we were advised of the Court's decision. Following this information, we were advised that individual districts could decide to release results with or without L.E.P. scores included. In a following memorandum from the Superintendent of Public Instruction, we were advised that as "agents of the State" we were bound by the Court's decision. A follow-up communication noted that we had discretion in releasing scores. A Court hearing on the matter was scheduled for July 16, 1998. An update on the outcome of the hearing and the district's actions with regard to release of S.T.A.R. results will be provided. Information only.

### A. Approve Routine Action Items by Consent (Cont'd)

6. Approve Resolution #99/03, Authorization to Conduct Surplus Sale
Throughout the year the Warehouse accumulates surplus items from throughout the District which are old, obsolete, non-repairable or uneconomical to repair. A list of such items is included in the supporting documents.

Education Code Section 39520 requires that items, whether one or more, having a value in excess of \$2,500 be sold to the highest responsible bidder. Education Code Section 39521-a allows that items, whether one or more, which do not exceed a value of \$2,500 may be sold at private sale without advertising. Section 39521-b allows that any items having previously been offered for sale pursuant to Section 39520, for which no qualified bid was received, may be sold at private sale without advertising; and Section 39521-c allows that property of insufficient value to defray the cost of arranging for a sale may be either donated to a charitable organization or disposed of in the local public dump.

The list of items included in the supporting documents exceeds \$2,500 in value and Administration recommends that the Board approve Resolution #99/03, Authorization to Conduct Surplus Sale. Administration further recommends that the Board direct the Director of Purchasing to dispose of unsold items at private sale pursuant to Education Code Section 39521-a, and that any item remaining after previous attempts at sale be donated to a recognized charitable organization or disposed of in the local dump pursuant to Education Code 39521-c.

### 7. Adopt Ordinance Nos. 99/01 and 99/02 Levying Special Taxes

(Mr. Edmunds)

The Board will recall that the District administers two Community Facilities Districts (CFDs). In December, 1990, CFD No. 1 of Jurupa Unified School District sold \$6.9 million dollars of bonds in order to finance school facilities (about \$1.3 million of the total) and water and sewer facilities for the Van Daele and Concordia developments within the CFD boundaries. Community Facilities District No. 2 sold \$1.25 million of bonds in March, 1993, to finance school facilities (\$195,000 of the total), and water and sewer facilities for an adjacent Van Daele development.

In order to pay the principal and interest on the outstanding bonds of these CFDs, the Board must adopt two ordinances levying special taxes on parcels of land within the CFDs. District counsel, Dick Anderson, has prepared the ordinances for levying assessment on these parcels. Special Tax Consultant, David Taussig & Associates, has prepared an analysis which determines the rate and method of apportionment of special taxes on the properties. This analysis is summarized in reports called <u>Community Facilities District Administration Report</u> (one for each CFD), which have been provided as supporting documents for Board members only. The ordinances and tax levy must be submitted to the Tax Assessor by August 10, 1998. It will be necessary for the District to levy special taxes within the CFDs in this manner on an annual basis as part of its responsibility as the lead agency administering the CFDs.

Administration recommends the Board adopt Ordinances Nos. 99/01 and 99/02, Urgency Ordinances Levying Special Taxes to be Collected During Fisca! Year 1998/99 for Payment of Principal and Interest on and Administrative Expenses with Respect to the Bonds of Community Facilities District No. 1 and Community Facilities District No. 2 of Jurupa Unified School District.

B. Approve Technology Use Plan

(Dr. Mason)

As the Board is aware, the Jurupa Unified School District has worked towards linking education and technology for several years. In 1990, the first Technology Use Plan was approved for distribution and use. During 1998, the Technology Services Department worked with a committee consisting of community members, parents, and staff to revise and update the Plan that has been reviewed and approved by district Administration and the district Technology Committee. A copy of the Technology Use Plan is included in the supporting documents.

It is recommended that the Board approve the Technology Use Plan submitted by the Technology Services Department for immediate implementation.

C. Approve Summer Learning Opportunity for Elementary Title I Students

Mr. Jim Owen, Principal at Van Buren Elementary School, is requesting permission to conduct a Summer Learning Opportunity for Title I students at Van Buren Elementary School. The classes offered will be conducted August 3 through August 21, 1998 from 8:45 a.m. to 11:45 a.m., and will focus on Language Arts and Mathematics. Transportation and breakfast will not be available; however, students will be encouraged to bring a snack. The budgeted cost of \$27,093 for the purpose of conducting this learning opportunity will be paid through Title I funds.

It is recommended that the Board approve the Title I Summer Learning Opportunity classes at Van Buren Elementary School August 3 through 21, 1998.

D. Review and Act on Timely School Facility Matters



Acceptance of the Grant Award - Action Required. Department of Education procedures regarding non-formula grant programs require that you confirm your formal acceptance of this grant award. To do this, complete the signature block at the bottom of the grant award form and return it to the Education Technology Office, California Department of Education, 515 L Street – Suite 250, Sacramento, CA 95814. Your prompt attention to this administrative requirement will be appreciated.

Fiscal Details. The specific school(s) to receive funding is (are) listed in the attachment to the Notification of Grant Award along with the grant amount approved for each school. (In a few cases, we have adjusted the amount of the state funds requested in the original application. In general, the change was necessary due to the applicant's error in calculating the amount requested on the application cover page.) We have already initiated the necessary internal fiscal procedures to distribute these funds. Grant award checks should be issued by the State Controller's Office in the near future.

Duration of the Grant Award. As indicated in the Comprehensive Application Guidelines, the duration of this grant award will cover a two-year period, from June 12, 1998, to June 30, 2000. With this extended period, no grant award extensions will be accepted. Because many of these grant awards are small, we encourage schools to complete their expenditures in a shorter period of time (i.e., according to the timeline in the school's application). Once expenditures are complete, a final project report must be submitted to you and your school board, with a copy transmitted via your California Technology Assistance Project (CTAP) to the CDE Education Technology Office. The final project report should be prepared as soon as the project staff has completed their implementation of the project.

COMMUNICATIONS SESSION

The Assistant Superintendent Education Services congratulated NASA scholarship recipient, Mission Middle student, Ms. Priscilla Bartel, for her winning essay that qualified her to receive an all expense paid one-week participation in NASA's Space Camp Program in Huntsville, Alabama.

## ACCEPT DONATIONS -Motion #1

The Assistant Superintendent Business Services requested that the Board accept six donations as listed on the Agenda.

MR. DEPARTMENT. MRS. BURNS SECONDED THE MOTION WHICH CARRIED UNANIMOUSLY.

# STATUS REPORT ON STAR TESTING

The Superintendent commented that Board members most likely read newspaper accounts regarding the release of S.T.A.R. test results on the Internet from tests given to students in grades 2-11 in April or early May. She stated that reports have indicated that a recent ruling by a San Francisco Judge barred the release of State test scores on the Internet until the Limited English Proficient (LEP) scores are disaggregated. Following that ruling, the Governor asked the court to overturn the ruling; however, his endeavors were unsuccessful. Therefore, the Superintendent stated that the decision remains as is until a hearing is held on July 16, 1998.

The Superintendent reported that the District required the assistance of nine additional employees to assist the Coordinator of Research and Evaluation, Mr. Gregg Nelsen, and his secretary, to mail individual student test scores on the State's new Standardized Testing And Reporting (S.T.A.R.) program to parents. Extra assistance was also provided by the Purchasing Department to place the proper postage on the reports. She noted that Mr. Nelsen has received a very small number of phone calls since the individual test scores were mailed out, and parents are happy to have received the information. The Superintendent further stated that on July 1, Harcourt-Brace, the Educational Measurement firm hired to score the individual S.T.A.R. tests, was contacted to request disaggregation of the district's data. The Superintendent learned in her conversation with Harcourt-Brace, that data disks sent to several districts were found to be faulty, and Harcourt-Brace will send replacement CD-ROMs. She stated that the district will work with another local school district to disaggregate the data and report to the Board accordingly.

Mr. Chavez inquired concerning needs assessments for Limited English Proficient students as test scores are reviewed and he emphasized the importance of documented test data noting the progress of L.E.P. students in order to address their needs.

The Superintendent responded that teachers will receive an extra copy of the data on individual student S.T.A.R. test results to review areas of need; in addition, she noted that the District currently maintains a base of information on Spanish language testing at the Assessment Center, and with the Stanford 9 results added, this will be another helpful tool in tracking student progress and determining the areas of need for L.E.P. students for the 1998-99 school year.

BOARD MEMBER REPORTS & COMMENTS Mrs. Burns and Mr. Chavez individually congratulated Mission Middle student, Priscilla Bartel, as one of NASA's scholarship recipients to attend their Space Camp in Huntsville, Alabama.

Mr. Chavez expressed his concern for the need to continue to provide Limited English Proficient students with a sound education.

BUDGET STUDY SESSION ON 9 SPECIAL FUND BUDGETS The Assistant Superintendent Business Services stated that as follow-up to the request from Mr. Chavez at the last Board meeting, he is providing a detailed overhead presentation (copies of overheads were distributed to the Board) on the nine special fund budgets, which, he noted, will be followed by a second Budget Study Session review of the General Fund Budget on August 3, 1998. He referred Board members to Special Fund Budget supporting documents from the June 15, 1998 Board meeting, and defined and profiled the revenue and expenditures for each of the following restricted funds: Adult Education, Cafeteria, Child Development, Deferred Maintenance, Capital Facilities, State School Building Lease-Purchase, Special Reserve, Tax Override and Self Insurance. Administration responded to Board members' discussion and questions on specific funds as follows:

•Adult Education Fund - the Superintendent explained that she received a memorandum from legal counsel regarding the Proposition 227 mandate for the State to set aside \$50 million in the State Budget to be distributed to school districts per ADA, Limited English Proficient count. She noted that as funds are distributed, districts may assign the money to Adult Education for English as a Second Language classes, to the County Office or to non-profit agencies; however, the key point of this section of the Proposition is that those adults that become English proficient as a result of the funding must provide tutoring to students who do not speak English. The Assistant Superintendent explained that the legislative change to actual attendance accounting for the 1998-99 school year will more than likely not cause a decrease in ADA funding, as there will be an adjustment in the base limit for individual districts. However, the district plans to continue its efforts to improve attendance.



BUDGET STUDY SESSION ON 9 SPECIAL FUND BUDGETS (CONT'D) •State School Building Lease-Purchase Fund - the Assistant Superintendent Business Services reviewed that the State allocated several years ago \$339,936 for advanced planning of a possible third high school. He noted that recent discussions with the State have included the possibility of reactivating this application for a five-year planning process.

•Child Development Fund - the Assistant Superintendent noted that the State Preschool program must be accounted for separately under the Child Development Fund, since it is a State program, with the interest specifically accounted for and accruals placed back into the project or returned to the State. He explained that all other categorical programs are included in the General Fund.

The Assistant Superintendent asked Board members to bring their 1998-99 General Fund Budget to the August 3, 1998 Board meeting for reference. He noted that he will place a reminder in the Agenda annotation to bring this document on that date.

AUTHORIZE NEGOTIATIONS FOR CFD NO. 3 -Motion #3 The Assistant Superintendent Business Services reported that there are plans by the MacMurray Family Trust, under the project management of Wellington Real Estate LTD, to build 410 single family homes on a 107 acre parcel of land north of the Mira Loma Middle School campus. He noted that the total mitigation fee amount for the planned homes is \$3,149,620, and the developer has requested the district to administer a Communities Facilities District (CFD) in order to finance the mitigation fees.

The Assistant Superintendent reviewed that the district currently administers two CFDs for the Loring Ranch Development and the Van Daele Development. The advantage to the district of forming a third CFD to finance mitigation commitments is that the fees will be paid in one lump sum prior to completion of the project, allowing for the planning and construction of permanent school facilities to house the students living in the new development. He noted that Special Tax Consultant, David Taussig & Associates, handles the levying of special taxes for the district's two existing CFD's and would do so for the third CFD, if so authorized. In addition, the mitigation agreement will be carefully developed by the district's counsel, Mr. Dick Anderson.

MR. TEAGARDEN MOVED THE BOARD AUTHORIZE THE ASSISTANT SUPERINTENDENT BUSINESS SERVICES TO NEGOTIATE A MITIGATION AGREEMENT WITH WELLINGTON REAL ESTATE LTD WHICH ALLOWS PAYMENT OF IMPACT MITIGATION FEES THROUGH FORMATION OF A COMMUNITY FACILITIES DISTRICT. MRS. ADAMS SECONDED THE MOTION. Following discussion, President Knight summarized the key items for the Assistant Superintendent Business Services to include in the negotiations process: the mitigation agreement will involve only one entity or the matter will be brought back to the Board for further review, and mitigation fees should be paid in one lump sum. A VOTE WAS TAKEN WHICH CARRIED UNANIMOUSLY.



### ORDINANCE NO: 99/01

AN URGENCY ORDINANCE LEVYING SPECIAL TAXES TO BE COLLECTED DURING FISCAL YEAR 1998-99 FOR THE PAYMENT OF THE PRINCIPAL OF AND INTEREST ON AND ADMINISTRATIVE EXPENSES WITH RESPECT TO THE BONDS OF COMMUNITY FACILITIES DISTRICT NO. 1 OF JURUPA UNIFIED SCHOOL DISTRICT

THE BOARD OF EDUCATION OF JURUPA UNIFIED SCHOOL DISTRICT DOES ORDAIN AS FOLLOWS:

School District (the "Board") levy special taxes pursuant to Sections 53340 and 53358 of the Government Code for the payment of the principal of and interest on the outstanding bonds of Community Facilities District No. 1 of Jurupa Unified School District, County of Riverside, State of California (the "District"), and for the payment of administrative expenses incurred in connection with the levy and collection of said special taxes and the payment of such principal and interest.

Section 2 Levy of Special Taxes. Special taxes shall be and are hereby levied for the fiscal year 1998-99 on all parcels of real property within the District and within Improvement Area No. 1 and Improvement Area No. 2 thereof which are subject to taxation, which are identified in Exhibit "A" and Exhibit "B" attached hereto, and in the amount set forth for each such parcel in said Exhibits "A" and "B". Pursuant to said Sections 53340 and 53358, such special taxes shall be collected in the same manner as ordinary ad valorem property taxes are collected and shall be subject to the same penalties and the same procedure, sale, and lien priority in case of delinquency as is provided for ad valorem taxes.

Section 3. Transmittal to County. The Clerk of the Board of Education shall immediately following adoption of this ordinance transmit a copy hereof to the Board of Supervisors

(A-7)

and the County Auditor of the County of Riverside together with a request that the special taxes as levied hereby be collected on the tax bills for the parcels identified in Exhibits "A" and "B" hereto, along with the ordinary ad valorem property taxes to be levied on and collected from the owners of said parcels.

Section 4. Authorization to Publish Ordinance. The President of the Board of Education shall sign this ordinance and the Clerk shall attest thereto and shall, within fifteen days of its adoption, cause it or a summary of it to be published in a newspaper circulated in Jurupa Unified School District.

Section 5. Urgency and Effective Date This ordinance is an urgency ordinance relating to taxes for the usual and current expenses of the District, i.e., the levy of special taxes to pay the principal of and interest on the outstanding bonds of the District. Accordingly, pursuant to Sections 36937 of the Government Code, this ordinance shall become effective immediately upon its adoption.

By Ordinance No. 99/01, the Board of Education of Jurupa Unified School District levied special taxes on parcels of taxable property within Community Facilities District No. 1 of Jurupa Unified School District, County of Riverside, State of California, in an aggregate amount necessary to pay principal of and interest on the outstanding bonds of that community facilities district. Such special taxes will be collected in the same manner as ordinary ad valorem property taxes are collected and will be subject to the same penalties and the same procedure, sale, and lien priority in case of delinquency as is provided for ad valorem taxes.

#### ORDINANCE NO. 99/02

AN URGENCY ORDINANCE LEVYING SPECIAL TAXES TO BE COLLECTED DURING FISCAL YEAR 1998-99 FOR THE PAYMENT OF THE PRINCIPAL OF AND INTEREST ON AND ADMINISTRATIVE EXPENSES WITH RESPECT TO THE BONDS OF COMMUNITY FACILITIES DISTRICT NO. 2 OF JURUPA UNIFIED SCHOOL DISTRICT

THE BOARD OF EDUCATION OF JURUPA UNIFIED SCHOOL DISTRICT DOES ORDAIN AS FOLLOWS:

Section 1. Findings. It is necessary that the Board of Education of Jurupa Unified School District (the "Board") levy special taxes pursuant to Sections 53340 and 53358 of the Government Code for the payment of the principal of and interest on the outstanding bonds of Community Facilities District No. 2 of Jurupa Unified School District, County of Riverside, State of California (the "District"), and for the payment of administrative expenses incurred in connection with the levy and collection of said special taxes and the payment of such principal and interest.

Section 2. Levy of Special Taxes. Special taxes shall be and are hereby levied for the fiscal year 1998-99 on all parcels of real property within the District which are subject to taxation, which are identified in Exhibit "A" attached hereto, and in the amount set forth for each such parcel in said Exhibit "A". Pursuant to said Sections 53340 and 53358, such special taxes shall be collected in the same manner as ordinary ad valorem property taxes are collected and shall be subject to the same penalties and the same procedure, sale, and lien priority in case of delinquency as is provided for ad valorem taxes.

Section 3. Transmittal to County. The Clerk of the Board of Education shall immediately following adoption of this ordinance transmit a copy hereof to the Board of Supervisors and the County Auditor of the County of Riverside together with a request that the special taxes as



levied hereby be collected on the tax bills for the parcels identified in Exhibit "A" hereto, along with the ordinary ad valorem property taxes to be levied on and collected from the owners of said parcels.

Section 4. <u>Authorization to Publish Ordinance</u>. The President of the Board of Education shall sign this ordinance and the Clerk shall attest thereto and shall, within fifteen days of its adoption, cause it or a summary of it to be published in a newspaper circulated in Jurupa Unified School District.

Section 5. Urgency and Effective Date. This ordinance is an urgency ordinance relating to taxes for the usual and current expenses of the District, i.e., the levy of special taxes to pay the principal of and interest on the outstanding bonds of the District. Accordingly, pursuant to Sections 36937 of the Government Code, this ordinance shall become effective immediately upon its adoption.

By Ordinance No. 99/02, the Board of Education of Jurupa Unified School District levied special taxes on parcels of taxable property within Community Facilities District No. 2 of Jurupa Unified School District, County of Riverside, State of California, in an aggregate amount necessary to pay principal of and interest on the outstanding bonds of that community facilities district. Technology, as a learning tool, will be used to improve the job performance of district employees and deliver a more effective educational program to students. Providing quality instruction is the driving force behind the district's technology plan, focusing on integrating technologies into the curriculum to improve learning so as to enhance the abilities of all learners. The appropriate use of technology encourages students and staff to problem solve, think critically, and develop lifelong learning skills.

### GOALS AND OBJECTIVES

#### Curriculum

## Goal 1: Support Curriculum Frameworks

**Objective1:** Provide cross-curriculum programs to meet the needs of all students. Strategies include broad-based programs in authentic assessment, individualized and self-paced programs, and technology competency milestones for K-12.

Objective 2: Integrate technology into district curriculum standards. Strategies to enhance learning skills include ready access to a variety of educational software, cable in the classroom, and lessons that engage the learner in mathematics, language arts, and other subjects.

Objective 3: Use technology tools to enhance the curriculum standards.

Strategies include forming a committee to review educational software in all subject areas and aligning of appropriate software with district curriculum standards.

# Goal 2: Support students' social, emotional, and physical well being.

Objective 1: Create an ethical and safe computing environment. Strategies include presenting new learning opportunities in networked resources; assuring the community that this information-rich environment will be safe for students and staff; teaching students to understand and respect the rights of others when using various technology; developing guidelines and standards for accessing the Internet and publishing on the Internet (i.e., procedures will address issues such as publication of student names and pictures, teachers' responsibility for students and students' responsibility for what they publish, and control of protected access to selected material).

**Objective 2:** Use technology to improve attendance and academic progress for students.

#### Instruction

# Goal 1: Use instructional technology effectively.

Objective 1: Empower staff to effectively use technology to enhance instruction and increase productivity. Strategies include ready access to technology resources and wide-ranging professional development activities.

Objective 2: Empower all students to use technology as a tool for effective communication, personal productivity, and lifelong learning.

Strategies include ready access to technology resources and an emphasis on developing powerful learning skills and a sense of personal comfort.



Objective 3: Investigate, pilot, and evaluate the use of instructional technologies and disseminate results. Strategies include supportive partnerships, careful evaluation of potential resources, and the use of pilot or trial programs prior to widespread adoption.

# Goal 2: Provide an intellectually challenging and developmentally appropriate instructional program for students.

Objective 1: Develop technology standards that are grade specific. Strategies to include forming a committee to determine skills to be developed at each grade level.

Objective 2: Evaluate the program developed to implement grade specific technology standards. Strategies include having the District Technology Committee review teaching strategies and evaluate resources that can help in the implementation.

# Goal 3: Support teaching and learning to meet curriculum standards.

Objective 1: Share information and examples of successful projects. Strategies include using electronically shared curriculum and developing electronic repositories for sharing information.

Objective 2: Provide training and resources to support teaching. Strategies include providing appropriate training to be able to use network applications along with workspace access to networked computers.

Objective 3: Provide presentation, research, and analytical skills. Strategies include enabling both staff and students to develop presentation, research and analytical skills. Networked computers will be provided first to the staff, so that they can develop appropriate skills, and then to the students.

# **Staff Development**

# Goal 1: Attract, develop, and retain highly competent and effective staff. Objective 1: Provide staff with access to technology in the classroom.

Objective 2: Through an established network, staff will be able to share resources and expertise, and have access to information for professional growth. Strategy includes building and expanding services for teachers and administrators who are new to the use of technologies and sustaining professional growth for teachers and administrators in using technology in the curriculum.

Objective 3: Provide sustainable momentum and incentives for teachers and administrators to continue seeking instructional technology training and professional development. Strategies include addressing individual needs of teachers and administrators with different levels of technology proficiency and working in different



program/subject areas, to use technology as a tool to enhance teaching and learning.

Objective 4: Integrate and align professional development and training services with education reform initiatives. Strategies include training for teachers, staff and administrators through commercial training companies, CTAP, and district trained personnel and coordinating workshops and training with neighboring districts' technology training centers.

Objective 5: Provide professional development opportunities for employees that focus on the issue of technology and learning. Strategies include supporting of existing programs that use technology to promote learning, piloting initiatives that integrate the use of technology with learning, and assessing the effectiveness of using technology to promote learning, in new and existing programs.

## Goal 2: School-based connection to technology planning.

Objective 1: Each school will establish and maintain an active technology planning process. Strategies include each site forming a technology committee to develop and implement the site's technology plan.

Objective 2: Evaluate the technology needs at each site. Strategies include the Educational Technology department meeting with the site-based technology committees to review technology needs. A survey will be developed to determine how the Educational Technology Department can support the technology and training needs of each site.

# Community

# Goal 1: Actively involve the community in the overall educational process.

Objective 1: Develop and utilize shared resources. Strategies include linking schools to the UCR-Library Project, providing access to the Educational Resources Information Center (ERIC), Robidoux Library - Access to Success: Electronic Research Training Program, Jurupa Recreation and Park District Center, and the Passport to College (Riverside Community College) program.

Objective 2: Develop partnerships with companies specializing in technology. Strategies include establishing internships and technology academies at schools.

# Goal 2: Provide the opportunity to community members to further their education.

Objective 1: Jurupa is committed to providing a variety of educational opportunities for adults and families to enhance their technology skills and help their children. Strategies include providing evening and Saturday classes at school libraries and parent centers.



- Objective 2: Develop procedures regarding community use of school labs, and opening labs to the community.
- **Objective 3:** Coordinate technology programs through the Parks and Recreation Department.
- **Objective 4:** Coordinate technology programs with an adult education program, which uses the school computers as teaching aids.

### Goal 3: Establish partnerships with external groups in terms of technology.

- **Objective 1:** Develop partnerships with local businesses.
- **Objective 2:** Develop partnerships with distance learning institutions

## Administration and Management

#### Goal 1: Increase Management and Administrative Effectiveness

- Objective 1: Develop an infrastructure with available technologies. Strategies include providing an adequate hardware platform for effective work output, adequate workspace access, and application software training for all staff in the district.
- Objective 2: Computerized documents for effective communications and portability. Strategies include archiving records, and policies and procedures. Automate grading and assessment records, attendance, health records, and reporting systems. Expand assessment to include options like portfolio management and self-evaluation. Provide compatibility between student data and assessment systems.
- Objective 3: Develop an implementation plan, in stages, to meet the district's goals. Strategies include efficiently managing the implementation of technology across the district, updating the district technology plan annually and evaluating individual schools needs with its technology and site plans. Maintain an inventory of the district's instructional technologies, and integrate and disseminate technology policies and procedures at all schools.

### Goal 2: Continue Improvement of Budgeting and Purchasing Process.

Objective 1: Purchase hardware platforms and software that are cost effective and reliable. Strategies include meeting computing needs with hardware platforms that are user friendly and standardizing application software used in offices throughout the district. Provide training for staff to assure that basic computer and technology skill levels are achieved. Maintain inventories of administrative hardware and software to continuously monitor progress toward standardization. Maintain the administrative server upgrading as necessary to reduce maintenance costs and provide increased access.



Objective 2: Evaluate the computing needs and effectiveness of the hardware and software programs being used. Strategies include surveying the needs of each site and disseminating information on costeffective hardware and software.

# Goal 3: Update the financial, student data, library, and purchasing systems to expedite the work process.

- Objective 1: Continue to evaluate technologies that reduce cost, and increase work flow. Strategies include developing teams to research and evaluate new financial, student data, library, and purchasing systems.
- Objective 2: Implement automated systems that effectively expedite the work process. Strategies include automating maintenance work order requests, transportation field trip requests, payroll, print requests, purchasing, food services, the district calendar and schedules, human resources information, job application forms, district personnel programs, and library systems.

# Goal 4: Provide leadership and support for the implementation of this plan.

- Objective 1: Provide information to the Superintendent/Board of Education on policy and procedure regarding compliance with legal issues. Strategies include The District Technology Committee recommending policies and procedures to the Board of Education regarding compliance with the Telecommunications Act 1996, copyright laws, and pertinent issues to the districts goals.
- Objective 2: Budgetary guidelines and facility standards will be developed by the Technology Steering Committee in conjunction with the district guidelines.
- **Objective 3:** Site levels, with district support, are encouraged to actively seek grant funding to expand technology.
- **Objective 4:** The District will coordinate technological projects that impact each site.
- **Objective 5:** The District Technology Committee has the final responsibility for the evaluation and revision of the district technology plan.

## Communication and Information Access

# Goal 1: Develop support system for classroom-to-world communication.

- Objective 1: Provide uniform connectivity throughout the district.
- **Objective 2:** Support information access in classrooms, schools, and community.
- Objective 3: Upgrade and automate the school library.
- Objective 4: Provide multiple network connection in the classroom infrastructure.
- Objective 5: Provide on-line access to school information. Strategies include training teachers and support staff to access and develop Web projects.



# Goal 2: Institute a communication system that supports classroom-to-world communication.

Objective 1: Connect to the World Wide Web and establish district and sites home pages. Strategies include installing 3 to 7 classroom workstations and expanding classroom technology to include audio-visual peripherals such as projectors, TVs and VCRs, and special equipment for common spaces such as auditoriums.

Objective 2: Provide teachers with workspace access to networked computers.

Objective 3: Provide training to all staff to take full advantage of available technology. Strategies include establishing systematic use and updating information posted on the Web and establishing a trainer of trainers program at school sites.

Objective 4: Provide guidelines for the home-to-school connections.

**Objective 5:** Provide hook-up to NovaNet Interactive Learning Program at the Adult School/Learning Center.

## Goal 3: Support Information Access in Classrooms.

Objective 1: School library automation and upgrade. Strategies include automating library card catalogs, providing audio-visual workstations, more networked computers to support simultaneous users and CD-ROM towers to provide shared resources.

**Objective 2:** Evaluate the libraries' automated systems. *Strategies include periodically evaluating the libraries' systems to update and improve information access.* 

#### Maintenance

# Goal 1: Develop a district wide maintenance program to provide a faultless network system.

Objective 1: Hire and train competent technicians to install equipment.

**Objective 2:** Provide a training program to help technicians stay current with new technologies.

**Objective 3:** Establish stipend positions at school sites to assist the district technicians.

**Objective 4:** Develop a School-to-Career program at the high school level to train students to install and maintain technical equipment.

# Recommendations from the Technology Committee

We recommend that the district adopt a multi-year plan, which would add computers to each school every year and also provide staff with the training necessary to make effective use of computer technology. We also recommend that the school sites purchase a mix of Macintosh and IBM or IBM-compatible computers, so that students and staff can have access to both of the dominant computer operating systems currently available. We recommend that the district office phase in the use of IBM or IBM-compatible



computers and develop a plan to distribute Macintosh computers to school sites for classroom use.

  - Use spreadsheets and databases and other analytical tools to assist in interpretation of data
  - Compile and present information contained in varied data types (graphics, charts, video, text, audio etc.)
  - Follow troubleshooting procedures to determine why a program does not run or equipment does not operate
  - Navigate network resources successfully
  - Select the most appropriate technology for a task
  - Observe instructional television programs that deliver instruction in the core curriculum
  - Use video technologies for reports and communication
  - Use E-mail and online resources
  - Practice the ethical and legal selection and use of technological resources
  - Understand and practice ethical and legal standards for communications through information technologies

#### 2. Connectivity

- ♦ All classrooms networked and connected districtwide
- ♦ Teachers and students have home-to-school access for E-mail and file retrieval
- ♦ Access to telecommunications services from multiple locations at every school site
- ♦ A FAX machine in each school
- ◆ Performance Results with classrooms networked and connected districtwide, telecommunications and home to school access established, all students and/or staff will:



- use information sources to find and retrieve information.
- gain access to at least one online service.
- collaborate with students in a wide range of environments.
- use online catalogs for research.
- search computer networks using file transfer methods and copy free software to their computer.
- participate in a news group discussion to communicate with others in various locations.
- access a local bulletin board system to gather and download multimedia information on topics being studied in school.
- monitor government services and legislative actions at the state, local or federal level.
- improve writing skills through telecommunications.
- Performance Results -- with a FAX machine in each school, all students and/or staff will:
  - have more timely access to time-sensitive new student records.
  - exchange information with other agencies.
  - send and receive information from public and private agencies.

### 3. Training and Support

- Lead and resource teachers will train staff.
- Media clerk training to use information resources.
- Budget allocation for computer upgrades and replacement.
- Performance Results -- with adequate levels of training/support available to staff and budgets established for computer and software upgrades, students and/or staff will:
  - have training and support available where and when needed.

    Lead and resource teachers will be available to train staff in effective use of technology in curriculum during the workday.
  - be comfortable and use technology.
  - be able to use the technology resources in the Guided Learning Centers.
  - have computers that have the memory and storage capacity to operate the software that supports the curriculum.
  - have equipment repaired and maintained in a timely manner.
  - apply ethical and legal standards in planning and implementing technology.

#### 4. Implementation

- ♦ Access
  - The site-based Technology Use Plan provides funding for each school to ensure access by acquiring hardware and software.
  - Each school's Technology Use Plan will address the following elements:
    - a program description addressing the curriculum priorities.
    - site-level assessment of needs, involving all members of the learning community.



- Selection of one or more of the following focus areas, with performance results and activities clearly described:
  - Instructional television;
  - Video production;
  - Computers as productivity and instructional tools;
  - Multimedia production;
  - Telecommunications;
  - Distance learning.
- Three-year plan describing how district and site resources will be used to support the plan.
- Evaluation strategies to demonstrate attainment of performance results.

### ♦ Connectivity

• The district will install local area networks at each school, and provide Internet and home to school connections.

### ♦ Training and Support

- Training and support for staff will be coordinated and provided centrally through the office of the Administrator of Educational Technology
- The following additional training and support activities will be required:
  - increased site-based training.
  - additional support for networking and equipment repair.
  - ongoing budget for upgrades for hardware and software.

# NETWORK ETIQUETTE RULES

**ELECTRONIC MAIL**. Electronic mail (e-mail) is not guaranteed to be private. Messages relating to or in support of illegal activities must be reported to the authorities. Do not respond to messages or bulletin board items that are suggestive, obscene, belligerent, or threatening.

**DISRUPTIONS**. Do not use the network in any way that would disrupt use of the network by others.

#### OTHER CONSIDERATIONS:

- Check for spelling errors and make sure your message is easy to understand and read.
- Use accurate and descriptive titles for you articles. Tell people what an article is about before they read it.
- Send your messages to only the most appropriate audience, not to "everyone."
- Remember that humor and satire is very often misinterpreted and may not be funny to some people.
- If you post to multiple groups, specify all groups in a single message.
- Cite references for any facts you present.
- Forgive the spelling and grammar errors of others.
- Remember that all network users are human beings. Do not "attack" correspondents; persuade them with facts.
- Post only to groups you know.

# Internet Electronic Information Services Acceptable Use Procedure: Rules and Regulations

The Jurupa Unified School District strongly believes in the educational value of Internet electronic services and recognizes their potential to support teaching and student learning. The purpose of the Acceptable Use Policy is to ensure that use of these services is consistent with the Jurupa Unified School District's stated mission, goals, and objectives. The District's electronic information services rely upon proper conduct by its students and personnel as well as adherence to strict rules and regulations governing acceptable use.

The rules and regulations governing the use of the District's electronic information services are listed below. Violation of any of the District's provisions could be cause for the denial of future access, termination of the user's account, and potential legal action. The user would be subject to disciplinary action according to the District's Discipline Policy.

Please read the contract carefully. When signed by you, and if appropriate, your parent/guardian, it becomes legally binding and certifies that you understand your roles and responsibilities when using the District's Internet Electronic Information Services.

Network etiquette shall be posted at all Internet sites, and teachers are encouraged to review these rules with students.

#### Terms and Conditions of this Contract

□ Teacher/Staff Responsibility As a representative of this school, I accept personal responsibility for reporting any misuse of the network to my teacher or an administrator. Misuse is most commonly viewed as any message sent or received that constitutes or suggests pornography, unethical or illegal solicitation, racism, sexism, inappropriate language, and other issues described below. It is understood, however, that controversial materials may sometimes be used in the context of a pedagogical purpose. The district deems such use appropriate. All the rules of conduct described in the school rules also apply when I am on the network.

□ Rules

The use of electronic information services must be in support of the educational goals and objectives of the District and used for educational research and professional duties only. General school rules for behavior and communication apply.

- Users are responsible for the proper use of their account and shall use only their own
  personal account number to access the electronic information service. Users shall
  not allow any other person to use their account, nor give their account number to any
  other person, on- or off-line.
- Users shall not give out their personal information or the information of others, such as their last, name, address, or phone number.
- Transmission of any restricted material in violation of any federal or state law or
  regulation is prohibited. This material includes, but is not limited to copyrighted
  material, threatening or obscene material, material protected by trade secret, or
  material construed as harassment or disparagement of others based on their race,
  national origin, sex, sexual orientation, age, disability, religion, or political beliefs.
  Users shall report any unsolicited mail or files of an inappropriate nature as listed
  above.



- Use of the electronic information services to encourage the use or sale of drugs, alcohol or tobacco, promotion of unethical or immoral practices, or any activity not allowed by the law or Jurupa Unified School District policy is prohibited.
- Use of electronic information services for commercial activities by a for-profit institution is generally not acceptable. Use of product advertisement or political lobbying is also prohibited.
- Use of electronic information services for personal financial or commercial gain is prohibited.
- Use of the electronic information services for plagiarism is prohibited. "Plagiarism" is defined here as the taking of ideas or writings from another person and offering them as your own. Credit should always be given to the person who created the article or idea.
- Student users shall not read other users' mail or files; they shall not attempt to interfere with other users' ability to send or receive electronic mail, nor shall they attempt to delete, copy, modify or forge other users' mail or files.
- Students' mail and/or files are considered student work and may be accessed by appropriate personnel.
- Use of any other organization's networks or computing resources must also comply with rules of that network.
- Messages of a private or personal nature involving students, staff, or other individuals are not permitted.
- Users will protect the electronic network. All users must scan any personal discs or software in a designated Virus Scanning Computer before using that disc or software in a networked computer.
- Users granted access to the Internet through the district information system assume
  personal responsibility and liability, both civil and criminal, for uses of the Internet
  not authorized by district policy. Users are considered subject to all local, state, and
  federal laws.

□ Privileges

The use of the district information system is a privilege, not a right, and inappropriate use may result in a cancellation of those privileges. Each person who receives an account will participate in an orientation or training course with a designated faculty member as to proper behavior and use of the network. The site system administrator operating under the authority of the Board of Education and the Superintendent will decide what is appropriate use and his/her decision is final. The system administrator may close an account at any time deemed necessary. Any staff member may request that the system administrator deny, revoke, or suspend a specific student account.
