RESOLUTIONS AND ORDINANCES ADOPTED

- Adopted Resolution No. 2026/23 to Commit Fund Balances
- Adopted Resolution No. 2026/24, Authorization to Conduct Surplus Sale, and authorize the Director of Purchasing to dispose of the unsold items pursuant to Education Code Section 17546, either by public auction, private sale, donation to a charitable organization, or disposal of in the local public dump
- Adopted Resolution No. 2026/25, Authorizing the Delegation of Authority to the Superintendent or Designee to Accept Completion of Public Works of Improvement, Approve the Recordation of the Notice of Completion, and any Other Action to Close Out Public Works Projects
- Adopted Resolution No. 2026/26, Annual and Five-Year Reportable Statutory School Fees and the Findings Contained in the Government Code 66006 and 66001 Annual and Five-Year Reports for Fiscal Year 2024/2025
- Adopted Resolution No. 2026/27, Approving Trustee Absence from Meeting
