School Board candidates for the November 2020 Governing Board Election were introduced.

RECOGNITION

- 1. President Silvia Ortega was presented with a plaque in recognition of her service as an outgoing member to the school district from December 2016 through November 2020 and as President of the Board of Education from December 2019 through November 2020.
- 2. The Board recognized Best of the Best recipients for August, September and October.
- 3. Mr. Doubravsky reported on the following grant award: Workforce Innovation and Opportunity Act, Title II: Adult Education and Family Literacy Act Grant, in the amount of \$224,068.00.
