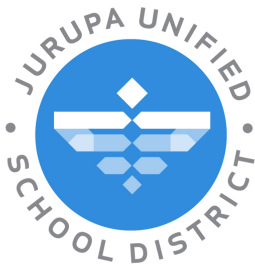

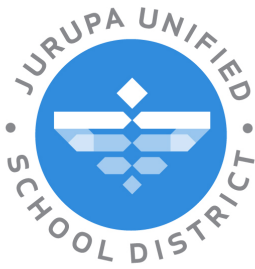
2. The Board approved the following change orders:
