WELCOME

School Board candidates for the November 2020 Governing Board Election were introduced.

RECOGNITIONS

Ms. Mariana Lopez, Census Coordinator shared a report on the 2020 Jurupa Community Census.

ADMINISTRATIVE REPORTS

Mr. Duchon gave a summary update on the COVID-19 situation and Riverside County being in the red tier. The Board will be holding a Study Session in regards to the reopening of schools.

APPROVALS/AUTHORIZATIONS

The Board granted the following approvals/authorizations:

- 1. The Board approved the issuance of a purchase order to the College Board, in an amount not to exceed \$155,000.00 for AP exams.
- 2. The Board approved the following changes to the original contracts issued for Bid No. 18-19-02PD the West Riverside Elementary School Addition & Modernization project:
 - Deductive Change Order # 002 Category 11 Glass & Glazing Queen City Glass Company. -\$4,411.00;
 - Deductive Change Order #001 Category 13 Acoustical Southcoast Acoustical Interiors, Inc. -\$6,054.16. In accordance with Public Contract Code Section 20118.4, no individual change order nor a combined total of all change orders by categories referred herein exceed 10% of the original contract price.
- 3. The Board accepted the Notice of Completion for Bid No. 18-19-02PD West Riverside Elementary School Category 01 Demolition and Earthwork.
- 4. The Board rejected all bids received for Category 11 Glass & Glazing and authorize the re-bid of Bid No. 2021-01PD Category 11 Glass & Glazing Jurupa Middle School Sitework & Addition Project.
- 5. The Board awarded the purchase of Chromebooks to ConvergeOne, in the amount of \$1,123,287.98.
- 6. The Board awarded the purchase of eBooks to Follett School Solutions, Inc., in the amount of \$500,000.
- 7. The Board awarded the purchase of makerspace furniture to Culver-Newlin, Inc., in the amount of \$359,791.41.
- 8. The Board awarded the purchase of ScreenBeams to Trox in the amount of \$342,153.87.
- 9. The Board awarded the purchase of laptops to ConvergeOne, in the amount of \$1,273,948.79.

- 5. New Board Policy and Administrative Regulation 3515.4, Recovery For Property Loss Or Damage; and the Deletions of Board Policy 1501, Recovery for Property Loss/Damage; and Board Policy 1502, Rewards for Information, were approved at a first reading.
- 6. New Board Policy 6157, Distance Learning, addresses the provision of distance learning opportunities to students, was adopted at a second reading.
