Jurupa Unified School District is pleased to announce online pre-enrollment for the 2020/2021 school year begins March 2, 2020 for **students new to the district** and must be completed prior to final registration. The pre-enrollment program is accessible from any internet connected device at <https://jurupausd.org> – Select the *2020/2021 Pre-Enrollment* link. If you do not have access to an internet connected device, computers are available at the Parent Center. There are no paper registration packets. All registration information is entered online through the pre-enrollment program, verified and finalized with Registration Staff at the Parent Center. Registration visits are on a first come, first served basis. **The registration staff will not be available June 29th – July 3rd to finalize registration.** The Parent Center is located at 4850 Pedley Road, Jurupa Valley, CA 92509 and may be reached at 951-416-1200.

To ensure you are able to complete the registration process, please bring the following documentation to the Parent Center:

Verification of Parent/Guardian Identity

Any one of the following items (with picture) is acceptable for the verification of identity:

- Current driver's license
- ID Card
- Passport
- Company/work ID
- Foster Care/Caregiver Documentation

Verification of Student Birth Date

Any one of the following items is acceptable for verification of date of birth:

- Birth Certificate
- Baptismal certificate duly attested
- Passport
- Adoption or Foster Care Record
- Hospital Birth Record
- Notarized Affidavit of Parent/Guardian with Birth Date

Verification of Residency-ONLY one of the following will be accepted:

- Current Utility Bill - Water/Electric/Gas/Trash (Cell phone bill is **not** acceptable)
- Current Property Tax Receipts
- Escrow Papers/Rental Agreement/Lease Agreement
- Employment Pay Stub
- Voter Registration
- Correspondence from a government agency
- Affidavit of Residency ***TO BE COMPLETED ONLY IF RESIDING WITH ANOTHER FAMILY.** We will need the completed affidavit and a current utility bill (within 30 days) in the person's name with whom you are residing.

Verification of Immunizations (see www.shotsforschool.org/K-12/link for appropriate dosage requirements)

- Doctor's Immunization Record/Yellow Card

Verification of Last School Attended, Student Grades & Language Assessment (not applicable if student has not attended school before)

- Transcript – Grades 7-12
- Last grade report card
- Withdrawal Documents
- CELDT/ELPAC Test Information (English Learners)

Current Physical Examination

Required for all kindergarten or 1st grade students. The physical exam must be given no earlier than six months prior to entry into kindergarten or no earlier than 18 months prior to the first day of 1st grade attendance at school. A physical exam is also required for all students (regardless of grade) entering from another country. Students transferring from another district or state must have the health examination included in their school record or they must repeat the examination.

- Oral Health Assessment
- Report of Health Examination for School Entry

Foster Student Placement Documents (if applicable)

Transitional Kindergarten Agreement (if applicable)

Please have the above applicable documentation with you at the time of your registration. If you are not able to provide all requested items, you will not be able to complete registration.
