SUBJECT: 2019/2020 Transportation Fees & Procedures

Please be reminded that all bus riding students must have a district issued bus pass prior to using Jurupa USD transportation services for the 2019/2020 school year. Students who require transportation per their Individualized Education Plan (IEP) and are assigned to a mini bus do not fall under this process and are not required to carry a bus pass.

Ensuring the safety of your child is our transportation department's first priority. For the safety of all students, each student will be issued a bus pass with a patented RFID code specific to him/her. This specific code provides critical ridership information to our dispatch center. Students will be required to scan their bus pass upon entering and exiting the bus. In the event of an emergency, dispatch will access the scanned information in order to provide information to parents of students who are shown to be on the bus. For this reason, **it is imperative that your child have their bus pass with them each day, scan the pass when they enter and exit the bus and never share their pass with another student.** Again, this is for the safety of your child.

Your child will receive one initial bus pass free of charge; however, if the initial bus pass is lost, stolen, damaged, breaks or is unable to be scanned, a replacement bus pass must be purchased for a fee of \$10.00.

Eligibility is determined according to the student's home address only. Students on an approved Inter or Intra District Transfer are not eligible for JUSD transportation services. The District offers transportation services for elementary students residing beyond a 2-mile walking distance from their resident school. Middle and high school transportation is available for Board approved middle/high school safety exception stops. You may check your students eligibility on-line at <https://mybus.jusd.k12.ca.us/elinkrp/Login.aspx>, username: Guest, password: jurupa.

The process for applying remains the same as last school year, on-line through www.mypaymentsplus.com.

NOTE: If you already created an account you do not need to create another, simply log in and apply for an annual bus pass at \$0.00.

The first initial free pass must be picked up at the Parent Center located at 4850 Pedley Rd, Jurupa Valley, CA 92509 prior to August 6th, see important dates below. Passes will NOT be mailed to the home address. **Students must have a pass on the first day of school to utilize services.**

Important Dates:

- Monday, July 1, 2019 – www.MyPaymentsPlus.com opens for on-line bus pass applications
- August 1, 2019 – Bus passes that have been applied for by July 19th may be picked up at the Parent Center at 4850 Pedley Rd. from 9:00 – 12:00 and 1:00 – 4:00.
- Friday, August 2, 2019 – Last day to apply for bus pass on www.MyPaymentsPlus.com to guarantee receipt of pass prior to the start of school.
- Monday, August 5, 2019 – FINAL DAY FOR PICK UP. Passes applied for between July 22nd and August 2nd may be picked up at the Parent Center until 4:00 p.m.
- Tuesday, August 6, 2019 – No bus pass pick up, passes not picked up prior to August 6th will be forwarded to the school sites for pick up on August 7th.
- All requests after August 2nd will be processed and sent to the school site. **(For the safety of all students, students may not ride the bus until they receive their bus pass, regardless of the date applied.)**
