## TO ALL BIDDERS:

The following changes, omissions, and/or additions to the Bid Documents and/or Project Manual and/or Drawings shall apply to proposals made for and to the execution of the various parts of the work affected thereby, and all other conditions shall remain the same. All parties of interest shall take careful note of the addendum so that the proper allowances may be made in strict accordance with the Addendum.

Bidder shall acknowledge receipt of this addendum in the space provided on the Bid Form. Failure to do so may subject Bidder disqualification.

In case of conflict between Drawings, bid documents and this addendum, this addendum shall govern.

| ITEM #1 | Clarification: At Peralta ES, the rod iron fence at the front of the campus WILL be painted |

ITEM #2 Clarification: The rod iron fencing at Granite Hill ES will NOT be painted.

ITEM #3 Clarification: The District will replace all rotted wood trim and siding at both Peralta ES and Granite Hill ES. All surface issues will be taken care of by the contractor in accordance with the project documents

ITEM #4 Clarification: At Peralta ES, the door number tag and/or name will be removed by the contractor, and new white 4" Vinyl numbers and/or letters will be installed by the contractor on the room door. At Granite Hill the contractor will re-install the 4" white vinyl rooms signage like for like.

ITEM #5 Clarification: At both Peralta and Granite Hills, painting of (2) 40' storage bins will be included in the base bid, the color will match the building's body color.

ITEM #6 Clarification: At Peralta ES, at the 2-story building, the stair hand rail will be painted to match the trim color.

The portable classrooms at Granite Hills ES will have a body, wainscot, and trim color. The portable classroom ramps will have a slip resistant coating applied as clarified in the project "Special Conditions" document, item 1. |
