TO ALL BIDDERS:

The following changes, omissions, and/or additions to the Bid Documents and/or Project Manual and/or Drawings shall apply to proposals made for and to the execution of the various parts of the work affected thereby, and all other conditions shall remain the same. All parties of interest shall take careful note of the addendum so that the proper allowances may be made in strict accordance with the Addendum.

Bidder shall acknowledge receipt of this addendum in the space provided on the Bid Form. Failure to do so may subject Bidder disqualification.

In case of conflict between Drawings, bid documents and this addendum, this addendum shall govern.

ITEM #1	Question: Can the District provide a list of the sites that need 10G, and/or 1G speeds?
	Answer: Schools and Sites on page 6 of the Bid Documents has been <u>revised</u> to include each site's required gigabit speed. See attached document to this Addendum. The total number of sites has not changed, nor has the quantity of 1G and 10G sites changed.
ITEM #2	Question: Will the service award be provided to a single provider or multiple providers?
	Answer: Per page 7 of the Bid Documents, bids that are determined to be responsive will be awarded to the bidder that scores the most points, based on a scoring matrix.
ITEM #3	Question: We did not see an upgrade path in the RFP, does the district believe they may need to upgrade sites within the term? And if so what sites and speeds?
	Answer: Page 30 of the bid documents asks for fixed pricing for both 1 and 10 gigabit connections. The District reserves the right to increase the speed of a 1 gigabit site to 10 gigabit site at the pricing listed on this document.
ITEM #4	Question: Would the District be willing to consider purchasing off of CALNET?
	Answer: No, this is a standalone RFP.

	Answer: Please list whoever designed, engineered, or architected the project, if applicable.		
ITEM #6	Question: We would like to request a one or two week extension of the bid deadline?		
	Answer: We are unable to accept requests for an extension of the bid deadline. The bid deadline remains on February 2, 2024, at 2:00 PM.		
ITEM #7	Attachment No. 0 to the Bid Form - Bid Price Calculation Worksheet and Questionnaire is modified to clarify as follows:		
	Remove: "All costs must be inclusive of any equipment, taxes and fees. Government taxes and fees should be excluded."		
	Replace with: "All one-time installation costs must be inclusive of any equipment, taxes, and fees. However, governing taxes and fees should be excluded from the ongoing service cost."
