Transfer Guidelines

- ◇ The Virtual program is contingent upon the general procedures and rules on which a transfer is granted. (see BP 5116.1 and AR 5116.1 for additional information)
- ◇ Enrollment is approved based on available space at a school and grade level. The district is required to reserve space at a school site to serve students who reside within the schools' attendance area.
- ◇ When promoting to 7th or 9th grade (elementary to middle school, or middle school to high school), a new transfer request must be submitted during the Open Enrollment period prior to the school year solicited.
- ◇ A transfer is granted in accordance with the Board regulations and the student shall abide by all school rules and procedures.
- ◇ If enrollment to virtual program is approved:
 - * **Parent/guardian must provide transportation at their own expense for their child to attend any in person meetings or expectations at school site**
 - * Student must maintain satisfactory attendance, scholarship, and citizenship.
 - * Student's enrollment may be denied or revoked if he/she fails to comply with school or district rules and regulations. (see below for more information)
- ◇ A student may have their enrollment denied, or revoked and be transferred back to their school of residence for any of the following reasons:
 - ◆ Unsatisfactory school attendance (including tardiness/late pick-ups)
 - ◆ Lack of acceptable academic progress
 - ◆ Repeated unacceptable behavior/discipline violations

Notification Timeline

- ◇ Notification of decision regarding your enrollment in the virtual program will be done in writing. Letters will be mailed no later than June 1, 2021, for applications submitted by May 10, 2021. If you do not receive a letter by June 15, 2021 please contact Jenna Saugstad at JUSD_Virtual@jUSD.k12.ca.us
- ◇ Applications received after Enrollment deadline will be reviewed but students may not be accepted into the program. Students must start school, in person, at their school of residence.
