Working through the SSC, the Annual TItle I meeting will be convened to share out the plan as well as taking feedback from parents to make any changes or additions. Relevant student data will be reviewed. The team will identify gaps in learning and develop plans to improve teaming for students. Parents are encouraged to attend SSC meetings and agendas are posted 72 hours before each meeting. Parent and educational partner feedback will be elicited each school year by Jurupa Unified School District. All available data sources are reviewed to support the creation of the Title I Parent Involvement Plan. Information is sent home to parents via phone calls, Class Dojo, emails, and hard copies. Individual student progress is reviewed at parent teacher conferences. Information is also shared with paents a the annual back to school night that is held at the start of each school year.
