2021-22 School Overview

Ina Arbuckle Elementary School is one of seventeen TK-6 elementary schools in the Jurupa Unified School District, and is located in Jurupa Valley, CA. The population of our community is very mobile. The majority of the students live within walking distance of the school in apartments, mobile home parks or rented homes, which contributes to a high transient rate. Ina Arbuckle Elementary School is located in one of several communities in the city of Jurupa Valley served by the Jurupa Unified School District, a district of approximately 20,000 students. Ethnic distribution is 91% Hispanic, 5% African American, 2% White (not Hispanic), and 2% other. Ina Arbuckle Elementary School is currently serving approximately 500 transitional kindergarten through sixth grade regular education students, 12 SDC Pre-K students, 38 Head Start children and 35 Spectrum students. According to CBEDS data, 93% of Ina Arbuckle students receive free or reduced lunch and 60% of students are English learners.

Optional Distance Learning, or In person daily "live" instruction is provided by appropriately certificated teachers who have been trained for effective distance learning teaching as well as in person instruction. Virtual instruction features appropriate opportunities for students to demonstrate learning, teacher feedback, formative assessments, student collaboration, and focused instruction.

All staff members are highly qualified. The Jurupa Unified School District actively seeks out highly qualified teachers and paraprofessionals through a variety of strategies. The district and site also provide quality, on-going staff development to ensure teachers and staff are effective. Teachers, paraprofessionals, and even parents are included in a myriad of trainings, which include, but are not limited to: G.A.T.E., Least Restrictive Environment, Positive Behavior Intervention Support (PBIS), Classroom Management, Student Study Team (Tier I/II Interventions), Restorative Justice Practices, Technology Integration, Professional Learning Communities, and School Safety training. Ina Arbuckle's staff collaborates with parents examining program effectiveness, school safety, and learning opportunities to provide a supportive, exemplary learning environment for all students. An active three-way partnership among teachers, parents, and students is the cornerstone to Ina Arbuckle's determination that all students succeed.

The Ina Arbuckle Elementary staff is dedicated to creating a safe and productive learning environment filled with positive school experiences. We are committed to:

2021-22 Quality, Currency, Availability of Textbooks and Other Instructional Materials

Jurupa Unified School District conducts an evaluation of instructional materials to adopt materials that best meet the needs of students. The district conducts adoptions on a districtwide basis. The review process includes a committee of a majority of classroom teachers in the appropriate discipline (Education Code Section 60210). In addition, all instructional materials are in compliance with social content standards. When making adoption decisions, the adoption committee uses the content standards, the curriculum frameworks, the State Board of Education-adopted evaluation criteria, and the reports on each adoption as resources. The final decision for selecting and recommending textbook adoptions is with the adoption committee. The most recently adopted textbooks were selected from the state-approved list.

All students, including English learners, have standards-aligned textbooks checked out to them, to use in class and to take home, in each of the core curriculum areas of reading/language arts, mathematics, science and history/social science; foreign language and health; visual and performing arts; and science laboratory equipment for grades nine through twelve as appropriate.

Elementary students receive core curriculum textbooks on the first day of enrollment. Middle school and high school students receive textbooks checked out to them at registration days a few days before the first day of school. All students enrolling after the first day of school have core curriculum textbooks checked out to them by the Library Clerk on their first day of enrollment.

School Facility Conditions and Planned Improvements

Our custodial staff, consisting of 1 daytime custodian and 2 evening custodians, perform basic cleaning operations in every classroom on a regular basis. The safety, cleanliness, and adequacy of our school facilities are a high priority to the District. Overall, school grounds and facilities are in good repair maintenance does an excellent job at maintaining the facilities. The District's Deferred Maintenance Plan is assessed and updated every year. Work generated by the Deferred Maintenance Plan is generally completed during the summer months. Fire inspections are conducted on an annual basis and any issues are addressed immediately. The District also has an internal inspection team conducting annual safety inspections of all sites. All safety-related items are handled as top priority.

Safety is maintained through the coordination and efforts of several different agencies, including the local fire department, Keenan and Associates (Administrator of Workers' Compensation), Industrial Indemnity (Liability Insurance Carrier), the district safety committee, and our own school custodians.

Ina Arbuckle Elementary School has 6 Activity Supervisors and 1 Campus Supervisor to support student safety. Ina Arbuckle Elementary School in accordance with Senate Bill 187 has safe school strategies that include information on the status of school crime and the following elements: Safe school programs; child abuse reporting procedures; disaster response procedures; suspension and expulsion policies pursuant to Education Code Section 48900, 48915, and 49079; the District's Discipline Handbook and Sexual Harassment Policy; our school dress code; and procedures and rules for safety on the way to and from school as well as during school hours. This plan will be updated every year and approved by our School Site Council by March.

Professional Development

Professional development opportunities are offered and modified to virtual means due to COVID-19. Ina Arbuckle staff kept up with best research-based teaching practices. Evaluation of the effectiveness of the previous year's staff-development activities are also reviewed annually. Individually, teachers identify strategies they'd like to add to their repertoires. From the data, professional-development priorities are established, with activities planned to meet those needs. Over the past few years. training initiatives included the implementation of new English Language Arts curriculum to address California Common Core State Standards for English Language Arts (RCOE, provider); Next Generation Science Standards (JUSD, Consultant provider); implementation of English Language Development Standards as a component of both Integrated and Designated English Language Development blocks (RCOE, provider); Behavior Social Emotional Learning (BSEL); JUSD Special Education Department, provider); Integration of HAIKU (Power Learning), ALLUDO technology training, and GAFE utilizing Chromebooks with a 1:1 ratio in grades 2-6 (JUSD Education Technology Department, provider with Virtual PDs for all staff); Five Easy Steps to a Balanced Math Program (Leadership and Learning Center training, provider); ELA and math Units of Study (Leadership and Learning Center Rigorous Curriculum Design consultants and Jurupa writing committee teachers, providers); Language! intervention teacher training (Voyager Learning consultants, provider); DIBELS Early Literacy teacher training (RCOE consultant, JUSD Early Literacy coach), transitional kindergarten teacher training (JUSD Education Services Professional Development Program, provider); and GATE teacher training (Dr. Susan Daniels, The Summit Center, provider). Staff also received training on trauma informed practices. These trainings provided teachers with the skills and tools necessary for implementing high-quality instruction to a range of students in their classrooms.

The 2021-22 planned professional development days include 64 partial days and 48 full days.
