2021-22 School Overview

Peralta Elementary School is a TK-6 elementary school in the Jurupa Unified School District. Peralta Elementary School is located in the city of Jurupa Valley, in Riverside County. It is a school wide Title I school with 514 students. All classrooms from transitional kindergarten through third grade participate in a flexible class size reduction program. Peralta teachers are fully credentialed, highly qualified, and EL authorized. There are currently 19 classroom teachers, three special education teachers, and 3 intervention teachers.

The school year consists of 180 days of instruction with 37 days being minimum days to allow for professional development and collaboration among teachers. Our staff has created a campus with a family friendly environment where all students and staff are given the best education possible as well as support in all aspects of the education process. Our campus is a closed campus where all visitors sign in at the front office. Students utilize Chromebooks to enhance their learning and are able to, at most grade levels, take the Chromebooks home in order to extend their learning opportunities within their individual homes.

The students at Peralta Elementary School are from diverse backgrounds. We have a majority Hispanic population representing 83% of our student enrollment. We are 9.5% White, 3.7% African American, 2.1% Asian/Pacific Islander, and .1% Native American. Our students receive an education that is tailored to not only their academic needs, but their language needs as well. We currently have 31% of students who are English Learners. Our free and reduced lunch rate is currently 47.08%.

Peralta has a collaborative and consultation service model for students in Individual Education Plans (IEP) receiving Resource Specialist services. We are an inclusion school for our special education students where they are able to remain in the general education classroom while receiving services and support. There is Speech and Language support on campus five days a week, counseling services available two days a week, and a Psychologist on site 2-3 days a week.

The three focus areas of the Local Control Accountability (LCAP) are addressed in the school plan. These areas include college and career readiness; safe, orderly, and inviting learning environments; along with student and community engagement.

Mission Statement: Peralta's mission is to create a positive learning environment that prepares students for career and college readiness.

Vision Statement:

Peralta Elementary School offers high quality educational programs that are both innovative and address California State Standards. Our expectation is that all students will excel in every academic capacity, and the school will have a reputation for high quality. At Peralta, we value the need to prepare students for college and career. We are an AVID ELementary School that shares the belief that it is our responsibility to provide every child with an education that prepares them for college. The entire Peralta staff is dedicated to providing an environment that promotes and reinforces a safe campus so that each student can attain his or her potential.

The school's educational programs will develop the academic, social, emotional, and physical well being of every student. Students will be well prepared to work independently and collaboratively to solve complex problems. Competent research skills will be an expectation for all students and each student will have a working knowledge of technology as a tool for learning in the 21st Century. Classrooms will be outfitted with appropriate high quality learning resources including Chromebooks for all students, document cameras, laptops, and projectors for all teachers.

An active parent partnership program will provide the parent community many opportunities to interact with their child's education both at home and at school. Adults will share the joys of reading success and encourage students to reach their full potential. Peralta believes that learning is a lifetime commitment for everyone.

2021-22 Quality, Currency, Availability of Textbooks and Other Instructional Materials

Jurupa Unified School District conducts an evaluation of instructional materials to adopt materials that best meet the needs of students. The district conducts adoptions on a districtwide basis. The review process includes a committee of a majority of classroom teachers in the appropriate discipline (Education Code Section 60210). In addition, all instructional materials are in compliance with social content standards. When making adoption decisions, the adoption committee uses the content standards, the curriculum frameworks, the State Board of Education-adopted evaluation criteria, and the reports on each adoption as resources. The final decision for selecting and recommending textbook adoptions is with the adoption committee. The most recently adopted textbooks were selected from the state-approved list.

All students, including English learners, have standards-aligned textbooks checked out to them, to use in class and to take home, in each of the core curriculum areas of reading/language arts, mathematics, science and history/social science; foreign language and health; visual and performing arts; and science laboratory equipment for grades nine through twelve as appropriate.

Elementary students receive core curriculum textbooks on the first day of enrollment. Middle school and high school students receive textbooks checked out to them at registration days a few days before the first day of school. All students enrolling after the first day of school have core curriculum textbooks checked out to them by the Library Clerk on their first day of enrollment.

School Facility Conditions and Planned Improvements

Our custodial staff, consisting of 1 daytime custodian and 1 evening custodian, perform basic cleaning operations in every classroom on a regular basis. The safety, cleanliness, and adequacy of our school facilities are a high priority to the District. Overall, school grounds and facilities are in good repair maintenance does an excellent job at maintaining the facilities. The District's Deferred Maintenance Plan is assessed and updated every year. Work generated by the Deferred Maintenance Plan is generally completed during the summer months. Fire inspections are conducted on an annual basis and any issues are addressed immediately. The District also has an internal inspection team conducting annual safety inspections of all sites. All safety-related items are handled as top priority.

Safety is maintained through the coordination and efforts of several different agencies, including the local fire department, Keenan and Associates (Administrator of Workers' Compensation), Industrial Indemnity (Liability Insurance Carrier), the district safety committee, and our own school custodians.

Peralta Elementary School has 8 Activity Supervisors to support student safety. Peralta Elementary School in accordance with Senate Bill 187 has safe school strategies that include information on the status of school crime and the following elements: Safe school programs; child abuse reporting procedures; disaster response procedures; suspension and expulsion policies pursuant to Education Code Section 48900, 48915, and 49079; the District's Discipline Handbook and Sexual Harassment Policy; our school dress code; and procedures and rules for safety on the way to and from school as well as during school hours. This plan will be updated every year and approved by our School Site Council by March.

Parent involvement is essential to student success at Peralta Elementary School. Teachers and staff make every effort to get parents involved in their child's education. They do this through constant communication, attentiveness to student needs, and providing opportunities for parents to be involved. Teachers and parents have two way communication through Class Dojo, and parents are sent information via Parentsquare, Facebook, PeachJar, the school marquee, and fliers. At these meetings, decisions are made that impact student learning and the running of the school. The School Site Council collaborates with the principal and staff to examine program effectiveness and site safety.

The Parent Teacher Association works to raise funds for students and teachers through a variety of fundraising opportunities. These funds are used to thank teachers for their hard work and to celebrate students. The PTA is an integral part of the Peralta family and they work tirelessly to increase parent and community involvement at the school site. School wide events are also planned by the PTA including but not limited to Red Ribbon Week, school carnivals and festivals, Book Fairs, the Annual Turkey Trot, Assemblies, and family nights.

An English Learner Advisory Committee (ELAC) advises the SSC, the principal, and staff on issues related to the education of English Language Learners. This team of parents also represents Peralta Elementary School at the district level. Professional Development

The Jurupa Unified School district is committed to providing high-quality, research-based professional development to all its teachers. Professional development continues to focus on ELA and Math Units of Study (Leadership and Learning Center Rigorous Curriculum Design consultants and Jurupa writing committee teachers, providers). There was also a focus on expanding Impact Team training and to scale up to other grade levels to increase teacher and student efficacy. Professional development will be provided to these new teachers in order to bring them along on the path of Impact Teams. Teachers will be trained on unpacking the CA State Standards, developing success criteria, and following up with the creation of assessments to determine student mastery of standards.

Professional development through ALLUDO allows teachers to self-select modules to meet their professional goals. These trainings provide teachers with the skills and tools necessary for implementing high-quality instruction to a range of TK-12 classrooms. Teachers and staff helped to identify safety and health concerns, technology/equipment needs, tools to support student engagement and digital learning and assessment. There is also training to support the social-emotional well being of students. Through professional development, teachers are able to collaborate with other teachers within their own school and among teachers from other sites.

By having site experts who receive additional training and professional development, teachers are able to gain new insights and understanding of how to increase their effectiveness. Each site has a technology teacher who is able to provide in depth professional development on technology integration and using technology to reach families. In addition, Balanced Math Facilitators support math instruction at each site.

The 2021-22 planned professional development days include 36 partial days and 1 full day.
