Conferences may be initiated by parents or teachers at any time during the school year. The counselor meets with all students to review their academic plan as well as behavior and attendance expectations.

- By the end of each quarter, parents are notified of final grades, but also receive progress reports mid-way during the term via Parent Connect.
- Parents may contact staff via, phone, email, or office visit. They may request an appointment with teachers and/or administration. Parents also can become involved in the School Site Council, the English Language Advisory Committee, and volunteer in the classroom and school events.
- Parents receive notification about important events and deadlines via Parent-Square, an online messaging system.

 Parents may contact the office or email teachers to set up appointments/conferences to discuss school related matters including academic progress, behavior, and attendance concerns. All communication from school to home is provided in the family's home language. Translation is also provided at parent meetings.
