Glen Avon Elementary has developed a written Title I parental involvement policy with input from Title I parents. The school convenes an annual meeting to explain our Title 1 program and inform parents of their rights to participate. Glen Avon also schedules regular flexible meetings with translation and childcare services. An annual survey for parents is conducted to assess our needs and evaluate the effectiveness of our programs. We provide timely information to parents about Title 1 programs via digital flyers, Parent Square, our website, phone messages, and social media, SSC, ELAC, Community School Meetings, and Booster Club. At parent conferences, we explain our curriculum, assessment information, student progress, and intervention programs. Students can participate by attending SSC, ELAC, and Booster Club meetings.

A flexible number of meetings will be held at varying times based on parent needs and will include child-care and translation services, if needed. Also, there will be a virtual option to support parents and their attendance at meetings if needed. Meeting agendas are posted, and information is shared electronically.

The SPSA is monitored and modified utilizing the feedback and input from parents.
