Some topics for general meetings may include: the schools' vision and mission, schoolwide learner outcomes (PRIDE), social emotional learning, counseling information (college applications, career information, financial aid, scholarships), school activities and governance, booster groups, drug awareness education, cultural awareness/proficiency, celebrations, and much more.

They can also provide input through school district surveys and more. Communication is further supported through the school's Wellness Center, offering additional resources for parents.

Meetings are advertised well in advance through multiple communication channels, including Parent Square notifications, emails, social media, and physical postings, to ensure that parents are informed and can plan accordingly.
