Call to Order was made at 11:10 am by Jennifer Briseño.

Welcome and Introduction was made Jennifer Briseño.

Flag Salute was made by Jennifer Briseño.

Roll Call was made by Ofir Adams and members were present except Cinthia Reyes and Cheri Davis.

Minutes from 10/18/19 meeting were reviewed by members present. Antonia Ortiz made a motion to approve the minutes, Jose Campos seconded the motion. The motion was carried. 6 yes, 0 no, and 0 abstentions.

Discussion Items:

1. **Soliciting Regional Representation-** Antonia Ortiz described as Home Visitation expands, we need reps from each region. Region was described as Zone 1 and it consist of: Jurupa Valley, Norco, Corona, Riverside, Moreno Valley, and Lake Elsinore. Parents as Teachers (PAT) will help to recruit reps as they will be in Zone 1.

2. **Update on Parents As Teachers (PAT)**- Jose Campos discussed that the final authorization to launch PAT will be provided soon by DPSS. Referrals will come from the CalWorks program with DPSS. Jennifer Briseño created a referral form with a release of information to be posted on our website and may be used at DPSS as a form to refer to the PAT program. As of today, 4 Home Visitors have completed training and 1 coordinator (will be included in these committee meetings in the future). Currently, 2 families participate in CalWorks and will begin Beta PAT services as they transition from FIRST Steps to PAT.
3. **CST/SST referral form**- Antonia Ortiz discussed the process which begins with staff addressing concerns and conducting observations, if needed. A form is filled out (currently pending) and goes to the Program Coordinator. The SST is then completed by the Home Visitor and meeting is scheduled to include: Parent, organization, nurse, community partner, JUSD, IRC (if possible). So far, 14 CST's have been completed this school year. This includes individualized parenting which is 1-1 limited parenting to meet specific needs, cannot exceed 120 minutes lifetime, and that can be broken up into 6 sessions.

Old/Other Business

Day of the Child – “Count Me In” : date has been set to March 26, 2020 from 11am – 1pm. It will include vendor booths, this will be the monthly HV group meeting event, a task force will be created, have a census tie-in and showcase PICO FRC services.
